# **ANZAC DAY 2023**







The State Government has acted to enhance the commemoration of ANZAC Day as a day of national significance.

### **ANZAC Day Commemoration Act 2005**

The object of the ANZAC Day Commemoration Act 2005 is to ensure that the contribution of all men and women who have served Australia in time of war or armed conflict, or in international peace-keeping operations, in which Australia has been involved, is recognised and commemorated in South Australia.

The *ANZAC Day Commemoration Act 2005* allows for the restriction of holding a public sports or entertainment event between the hours of 5.00 am and 12 noon on ANZAC Day in any year.

This restriction applies to any organisation who proposes to, or would normally, conduct a public sports or entertainment event on ANZAC Day.

## ANZAC Day is Tuesday, 25 April 2023

### **Public Sports and Entertainment Events**

In accordance with the *ANZAC Day Commemoration Act 2005*, a public sports or entertainment event is defined as:

A sporting or entertainment event or activity to which tickets for admission (or similar devices) -

- Are made available for purchase by a member of the public prior to the holding of the event or activity; and
- Are required for entry to the event or activity.

The intent of the ANZAC Day restriction is not to limit the community's participation in recreation and sport.

Regular sporting events and junior sport can go ahead as normal. Venues such as golf courses, recreation/basketball/netball centres and fitness centres etc. can open as they would normally do, the restriction does not apply to participation in sport and recreation.

Unless tickets will also be sold to the public prior to the event and these tickets are required for entry, where a venue such as a recreation/basketball/netball centre normally charges parents a spectator fee on the day at the door or country football normally charges a spectator entry fee on the day at the gate they can still do this.

## **ANZAC** Day event checklist

The following checklist may help to determine if your event or activity is impacted:		
Is this a public sporting or entertainment event or activity, for example is the emphasis on attending rather than participating?	Yes	□No
Is there a ticket (or similar device) sold for admission to the event?	Yes	□No
Are tickets available for purchase by members of the public prior to the holding of the event?	☐ Yes	□No
Is a ticket (or similar device) required to be produced to gain entry to the event or activity?	☐Yes	□No
If you have ticked <b>yes to all of the above</b> , then the event is restricted under the <i>ANZAC Day Commemoration Act 2005</i> .		

## **Exemptions**

The ANZAC Day Commemoration Act 2005 does provide for exemptions to the restrictions on public sporting and entertainment events which are in the public interest.
