## INTRODUCTION

## What is the Anzac Day Commemoration Fund?

The Anzac Day Commemoration Fund was established by the *ANZAC Day Commemoration Act 2005* ('the Act'). The Act states that the Fund may be applied by the Minister for Veterans' Affairs after consultation with the Veterans' Advisory Council.

Each year, the Fund offers an opportunity for organisations to apply for financial support for projects that commemorate our military history, foster public understanding of its significance, and benefit the veteran community.

Under this Fund, a maximum of \$100,000 in grant funding is available for distribution in the 2025-26 financial year.

The Anzac Day Commemoration Fund is administered through Veterans SA, which provides the administrative support for an annual competitive grants process to distribute payments from the Fund.

# **ELIGIBILITY CRITERIA**

# What type of projects can the grant be used for?

Under the Act, the Fund may only be applied for specific purposes. Grants from the Fund in 2025-26 may be used for:

- projects conducted by an organisation established for the purpose of helping or supporting, or having a membership consisting of or including, veterans or the spouses, domestic partners, children or other dependants of veterans (such as an ex-service organisation),
- projects with the purpose of educating the community about the significance of Australia's military history,
- projects with the purpose of conducting services to commemorate Australia's military history.

South Australian RSL sub-branches are encouraged to apply to the RSL SA State Branch for funding to deliver Anzac Day services.

Grants will not be distributed for:

- any projects which do not align with any of the specific purposes listed above from the ANZAC Day Commemoration Act 2005
- applicant organisations which are not based in South Australia
- ongoing expenditure (such as electricity bills or wages)
- major capital works
- annual events beyond their first year. Note: applicants may apply for seed funding for the first year of an event planned to become an annual occurrence
- food or catering

- · costs relating to existing staff salaries
- · travel, accommodation or entrance fees
- retrospective funding for projects already completed.

# Which organisations are eligible to apply?

Organisations are eligible to apply if they are:

- an incorporated organisation established for the purpose of helping or supporting, or having a
  membership consisting of or including, veterans or dependants of veterans. This includes exservice organisations.
- A local government authority, a school, or an incorporated not-for-profit organisation, provided that the applicant's project has the purpose of educating the community about the significance of Australia's military history or commemorating or honouring Australia's military history.

In addition, applicant organisations must:

- have an ABN
- have met requirements for any previous grants received from Veterans SA, such as acquitting or reporting on grants.

Organisations not meeting these requirements, such as unincorporated organisations, may partner with a lead applicant that meets eligibility requirements.

Applications must be authorised by an appropriate executive member of the organisation. Incomplete applications will not be accepted.

An applicant may only submit one application. Should an applicant submit two or more applications, all those applications may be deemed ineligible.

# **GRANT AMOUNT & GRANT PERIOD**

# What amount of funding is available?

Under this Fund, a maximum of \$100,000 (ex GST) in grant funding is available for distribution in the 2025-26 financial year.

The Government of South Australia reserves the right not to distribute the full amount.

# How much can I apply for?

There is no minimum or maximum funding amount that can be applied for within the total \$100,000 that is available for distribution this grant round.

The grant process is competitive, and applications may either be funded in full, partially funded or not funded at all.

# When are applications due?

Applications for the 2025-26 funding round close at 5.00 pm ACST on 31 October 2025.

Late applications will not be considered.

# **ASSESSMENT PROCESS & CRITERIA**

## What is the grant assessment process?

After you submit an application, you will receive a receipt confirmation via email.

#### Stage one - Application screening

Once the round has closed (5.00pm, ACST, 31 October 2025), Veterans SA will screen all applications to check that:

- the applicant and project are eligible ineligible applicants or projects will not be progressed to assessment.
- the application has been completed in full and all supporting documentation has been provided – incomplete applications will not be progressed further.
- the applicant does not have any outstanding obligations for previously awarded grants –
   applicants with outstanding obligations will not be progressed further.

#### Stage two - Assessment against criteria

Applications that progress to stage two will be assessed by an assessment panel comprising members of the Minister's Veterans' Advisory Council (VAC), Veterans SA, and / or individuals with extensive experience in or with the veteran community.

- The panel will assess each application on merit, based on how well it meets the evaluation criteria and how it compares to other applications.
- The panel will seek endorsement from the VAC.
- The VAC will review the panel's assessment and make recommendations to the South Australian Minister for Veterans' Affairs.
- Per the Act, the Fund may be applied by the Minister, after consultation with the VAC.

At any stage during the process, applicants may be contacted for clarification on their application.

# **OFFICIAL**

The panel will assess eligible applications against the following evaluation criteria:

1. Project planning and impact (25%)	<ul> <li>Does the application clearly define the project's outcomes?</li> </ul>
	<ul> <li>Does the application describe how the impact of the project would be measured?</li> </ul>
	Are there realistic project plans and milestones?
2. Value for money (25%)	<ul> <li>Would the project provide value for the South Australian community using government money?</li> </ul>
	<ul> <li>Would the project be sustainable after completion and not create an ongoing need for funding from government?</li> </ul>
	<ul> <li>Are there commitments of co-contributions from the applicant or another organisation where appropriate?</li> </ul>
3. Contribution to the Community (20%)	<ul> <li>Does the application clearly identify how the project will contribute to the community?</li> </ul>
	<ul> <li>Would it complement rather than duplicate what is already existing in the community?</li> </ul>
4. Addressing an Identified Need (15%)	<ul> <li>Does the application identify a need and describe how the project would address the identified need?</li> </ul>
5. Organisational capacity (15%)	<ul> <li>Does the application include evidence that the applicant organisation has capacity to deliver the proposed project and achieve the stated outcomes?</li> </ul>
	<ul> <li>Does the applicant have the necessary skills, knowledge and experience to deliver the project?</li> </ul>

Please note, only evidence presented in the application will be assessed.

# **HOW TO APPLY**

## What documentation is required?

If you are an organisation established for the purpose of helping or supporting, or having a membership consisting of or including, veterans or dependants of veterans, evidence is required, such as a copy of your constitution or other governing documents.

Quotes are required for items requested for funding with a value over \$1,000 (ex GST).

A covering letter or references are not required.

## What should I consider when preparing an application?

- Make sure you include all attachments and essential documentation where requested, including quotations for items valued over \$1,000 (ex GST).
- Putting together a strong application takes time, so please read the guidelines carefully, complete the application in full and answer all the questions provided.
- Read the evaluation criteria carefully to ensure that your application identifies how your project meets the criteria and will add value and contribute to the community.
- Funding requests for commemorative publications should include a proposed distribution list to enable an informed decision to be made based on the anticipated community reach and benefit of the project.
- Applications for projects over \$10,000 (ex GST) must include evidence that alternate funding sources have been explored. Co-contributions from the applying organisation may be considered favourably.

Consortiums or partnerships may be considered favourably. Note, that one organisation must be nominated as the lead agency for the project and will be responsible for the receipt and acquittal of grants funds.

# How do I submit my application?

# NOTIFICATION OF APPLICATION OUTCOMES

# How will I be notified of the outcome of my application?

Veterans SA will notify applicants of the outcome of their application in writing before 31 December 2025.

At any stage during the process, applicants may be contacted for clarification on their application.

Unsuccessful applicants may contact the Veterans SA team at <u>vsafundapplications@sa.gov.au</u> to receive feedback on their application.

# What happens if my application is successful?

If your application is successful, you will be notified by email.

A grant agreement from Veterans SA will follow for your consideration and completion. The grant agreement will set out the conditions of the grant, including the outcomes proposed in your application as well as the acquittal and reporting requirements.

An authorised officer at your organisation must sign and return the grant agreement to receive the grant funds.

# What are my obligations?

Successful applicants are required to acknowledge support from the Government of South Australia. Receipt of the grant must be publicly acknowledged in any programs, correspondence or promotion of the event.

- Grant funding must be expended by the agreed project end date, as outlined in the funding
  agreement. Extensions may be considered only where prior approval has been granted by
  Veterans SA. Funds must be spent on the project as described in the application and as
  executed in the grant agreement. No portion of the grant funding can be expended on items
  not listed in the grant agreement.
- Your organisation must seek approval in writing from Veterans SA for any alterations to the approved project before the project completion date.
- Any unspent funds must be returned to Veterans SA, the administrators of the fund.
- The grant must be acquitted in accordance with the requirements of the grant agreement.
- Your organisation must retain and provide Veterans SA with copies of receipts for all grant expenditure. You must maintain records of expenditure for at least five years.

# What other funding options are available?

The <u>Veterans SA</u> website provides information about several veteran-specific grant funds available through State and Commonwealth governments.

Check with your local council to see if your project aligns with any of its grant programs.

The <u>Government of South Australia</u> has a number of grant opportunities for communities, clubs and individuals.

The <u>Department of Veterans' Affairs</u> also offers a number of grants, including the Saluting Their Service Commemorative Grants Program.
